INVESTMENT OBJECTIVE







MANAGEMENT COMMENTARY (QUARTERLY)

SG Credit Millésime 2028 was launched in March 2023, with AuM that grew steadily until the end of its subscription period (~€562 million at Q4-end). The fund displays a total performance of +0.86% over the quarter (+4.26% year-to-date) as well as a solid credit profile, with 73.8% of Investment Grade rated bonds, and a high issuers diversification (103 positions for 91 unique issuers). This comes with a strong green & social bond allocation, representing a total of 71.7% of total investments as of December 31st. The fund displays a current yield-to-convention at 3.53%.
