## WHAT IS THIS PRODUCT?

**Type:** This product is a share of a Sub-Fund of Moorea Fund

**Term:** The Fund has no maturity date but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

**Objective:** **Investment objective:** The investment objective of the sub-fund is to seek regular income by investing primarily in Euro denominated debt. The sub-fund aims at meeting the long-term challenges of sustainable development while delivering financial performance by the combination of financial and extra-financial criteria, integrating ESG.

**Investment policy:** The Sub-Fund will invest predominantly in Euro denominated debt securities and related instruments domiciled in European countries (minimum 80% of the assets of the Sub-Fund). Up to 20% net assets may be invested in non-Euro denominated fixed income securities.

The average duration of the portfolio will be typically between 1 and 8 years.

The Sub-Fund may invest in the following securities:

- Debt instruments issued by governments, State agencies or by supranational entities
- Corporate debt instruments principally rated Investment Grade. It may also opportunistically invest in debt securities rated below Investment Grade with a rating of at least B-/B3 (up to 40% of the Sub-Fund's net assets)
- Debt instruments such as bonds with fixed coupon, variable coupon, floating coupon, step coupon, indexed coupon or zero coupon
- Convertible bonds and structured products (up to 10%). The Sub-fund will mainly invest in structured products designed to provide exposure to a certain interest rate, interest rate spread, credit spread, or currencies. The Sub-Fund may also invest on an ancillary basis in structured products indexed on equity indices or equities. Structured notes may or may not bear capital guarantee at maturity, by the issuer.
- Money Market Funds (up to 20%).

**SFDR Category:** Article 8. The Investment Manager addresses ESG factors throughout the investment process by incorporating an exclusion policy completed by an ESG Integration policy.

**Benchmark:** The Sub-Fund is actively managed without reference to a benchmark. For the purpose of performance comparison only, the return of the Sub-Fund will be compared to the following benchmarks: Ice Bofa 3-5 Years Euro Corporate Index, Ice Bofa 3-5 years Euro government Index, ESTER.

**Income:** Accumulation share class, the dividend is reinvested.

**Investment horizon:** The risk and the reward of the product may vary depending on the expected holding period. We recommend holding this product at least for 5 years.

**Currency:** Your shares will be denominated in Euro, the Fund's base currency.

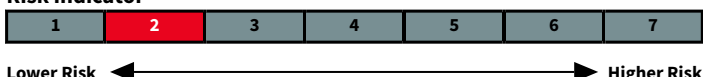
**Processing and redemption orders:** You can buy and sell your shares daily.

**Depository:** Société Générale Luxembourg

**Intended Investor:** This share class is intended for professional investors and eligible counterparties. The fund is dedicated to investors who seek growth of capital and may bear total capital loss. Potential investors should have an investment horizon of at least 5 years.

### Risk indicator

## WHAT HAPPENS IF Société Générale Private Wealth Management S.A. IS UNABLE TO PAY OUT?

Société Générale Private Wealth Management (SGPWM) is a management company licensed and supervised by the CSSF. SGPWM complies with organizational and operational rules, in particular as regards capital requirements. A separate pool of assets is invested and maintained for each Sub-Fund. The assets and liabilities of the Sub-Fund are segregated from those of other sub-funds as well as from those of the management company, and there is no cross-liability among any of them. The Sub-Fund would not be liable if the management company or any delegated service provider were to fail or default.

## WHAT ARE THE COSTS?

The Reduction in Yield ("RIY") shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. The figures are estimates and may change in the future. You should note that these costs are paid by the Company whereas the return that you may receive will depend on the Company's share price performance. There is no direct link between the Company's share price and the costs that it pays.
