WHAT IS THIS PRODUCT?

Type: This product is a share of a Sub-Fund of Moorea Fund

Term: The Fund has no maturity date but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

Objective: Investment objective: The Sub-Fund seeks to achieve performance through investments in diversified portfolio of debt instruments on issuers with a strong ESG (Environmental Social and Governance) profile, principally denominated in Euro. The Sub-Fund aims at meeting the long-term challenges of sustainable development while delivering financial performance by the combination of financial and extra-financial criteria, integrating ESG criteria.

Investment policy: The Sub-Fund will invest in a diversified portfolio consisting primarily of high yield debt securities issued by governments, corporations or public institutions, mainly denominated in Euro. High Yield encompasses bonds rated BB+ and below by Standard & Poor's or equivalent to BB+ and below in the opinion of the investment manager. The Sub-Fund may invest in securities rated at least B- at the time of their investment and in securities which are not rated if they are considered to be equivalent in risk to at least a B- rated company in the opinion of the investment manager at the time of investment.

The Sub-Fund can invest to a lesser extent in: High Yield debt denominated in USD (up to 40%), Additional Tier 1 Bonds (up to 20%), Convertible bonds (up to 25%) and Investment Grade debt securities (up to 10%). These debt securities will be issued by foreign corporations or governments or governmental agencies or instrumentalities.

Currency risk resulting from investments in non-EUR denominated debt securities might be hedged against the EUR.

SFDR Category: Article 8. At each step of the management process, the Investment Manager exploits both financial analysis and socially responsible investing approach. The Investment Manager addresses ESG factors throughout the investment process, including research, company engagement and portfolio construction. The Investment Manager incorporates an exclusion policy completed by an ESG Integration policy. This two-fold SRI approach will lead to exclude at least 20% of the initial investment universe.

Benchmark: ICE BofA Euro High Yield Index; ICE BofA US High Yield Index; ICE BofA Contingent Capital Index; ICE BofA Global Convertible Index; ICE BofA Euro Corporate Index.

Income: Accumulation share class, the dividend is reinvested.

Investment horizon: The risk and the reward of the product may vary depending on the expected holding period. We recommend holding this product at least for 3 years.


Currency: Your shares will be denominated in USD, the Fund's base currency is EUR.

Processing and redemption orders: You can buy and sell your shares daily.

Intended Investor: This share class is intended for all investors. The fund is dedicated to investors who have neither financial expertise nor any specific knowledge to understand the Sub-Fund but nevertheless may bear total capital loss. It is suitable for investor who seeks growth of capital. Potential investors should have an investment horizon of at least 3 years.

WHAT ARE THE RISKS AND WHAT COULD I GET BACK IN RETURN?

Société Générale Private Wealth Management (SGPWM) is a management company licensed and supervised by the CSSF. SGPWM complies with organizational and operational rules, in particular as regards capital requirements. A separate pool of assets is invested and maintained for each Sub-Fund. The assets and liabilities of the Sub-Fund are segregated from those of other sub-funds as well as from those of the management company, and there is no cross-liability among any of them. The Sub-Fund would not be liable if the management company or any delegated service provider were to fail or default.

WHAT ARE THE COSTS?

The Reduction in Yield ("RIY") shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. The figures are estimates and may change in the future. You should note that these costs are paid by the Company whereas the return that you may receive will depend on the Company's share price performance. There is no direct link between the Company's share price and the costs that it pays.
