# WHAT IS THIS PRODUCT?

**Type**: This product is a share of a Sub-Fund of Moorea Fund

**Term**: The Fund has no maturity date but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation. **Objective**:

Investment objective: The Sub-Fund Moorea Fund-Target Return Fund objective is to generate a total return which exceeds UK inflation by a margin of 5% p.a. over the medium to long term.

Investment policy: The Sub-Fund will invest its assets without constraint in terms of geographical, currencies or sectorial focus. The Sub-Fund seeks to achieve a total return by investing directly or indirectly in fixed income, floating rate securities, directly or indirectly in equities, in Hedge strategies that are eligible investments in line with the investment policy and strategy of the fund and finally in money market securities. The ETF funds and the funds in which the Sub-Fund will invest will be submitted to a supervision and a diversification of risks equivalent to those applicable to UCITS funds. The Sub-Fund may also invest in a selection of underlying funds investing in all kind of authorised assets and in funds which are subject in their home country to a supervision considered by the Luxembourg Supervisory Authority as equivalent as that laid down in Community legislation (European Union, Canada, Hong Kong, Japan, Switzerland, United States of America) and in structured products (EMTN and certificates qualified as transferable securities).

Benchmark: The Sub-fund is actively managed with reference to the following benchmark: UK CPI + 5%. The benchmark is used for performance comparison.

Income: Distribution share class, the dividend is paid quarterly.

Investment horizon: The risk and the reward of the product may vary depending on the expected holding period. We recommend holding this product at least for 3 years.

Currency: Your shares will be denominated in GBP, which is the Fund's base currency.

Processing and redemption orders: You can buy and sell your shares daily.

Depositary: Société Générale Luxembourg

**Intended Investor**: This share class is intended for professional investors and eligible counterparties. The fund is dedicated to investors who seeks growth of capital and may bear total capital loss. Potential investors should have an investment horizon of at least 3 years.

# WHAT HAPPENS IF Société Générale Private Wealth Management S.A. IS UNABLE TO PAY OUT?

Société Générale Private Wealth Management (SGPWM) is a management company licensed and supervised by the CSSF. SGPWM complies with organizational and operational rules, in particular as regards capital requirements. A separate pool of assets is invested and maintained for each Sub-Fund. The assets and liabilities of the Sub-Fund are segregated from those of other sub-funds as well as from those of the management company, and there is no cross-liability among any of them. The Sub-Fund would not be liable if the management company or any delegated service provider were to fail or default.

## WHAT ARE THE COSTS?

The Reduction in Yield ("RIY") shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. The figures are estimates and may change in the future. You should note that these costs are paid by the Company whereas the return that you may receive will depend on the Company's share price performance. There is no direct link between the Company's share price and the costs that it pays.
