WHAT IS THIS PRODUCT?

Type: This product is a share of a Sub-Fund of Moorea Fund

Term: The Fund has no maturity date but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

Objective: **Investment objective:** The Sub-Fund seeks to provide long-term capital appreciation over a cycle of 5 years, primarily through investments in a portfolio of European Equities. The aim of the Sub-Fund is to identify companies that exhibit sustainable quality and income characteristics.

Investment policy: In order to achieve its investment objective, the Sub-Fund will invest at least 70% of its assets in equity securities of companies domiciled in or exercising the predominant part of their economic activities in Europe. The Sub-Fund will principally invest in European large cap equities (issued by companies with a capitalization of at least 5 billions EUR at the time of purchase).

The Sub-Fund aims to deliver a smoother risk adjusted return profile than the broader European equity market in combining both quantitative screening criteria and fundamental stock selection.

SFDR Category: Article 8. The fundamental stock selection exploits both financial and extra-financial analysis. The extra-financial analysis uses ESG data with a scoring methodology. Integrating these criteria aims at selecting the companies having the best capacities and capabilities to reach their financial objectives while being the model corporate citizens in today's challenging economic, political and climate environment. The portfolio will be mainly invested in stocks of companies exhibiting "High Quality" factors: regular dividend yields, high visibility on company business activities, consistent risk/adjusted return while mitigating volatility at a portfolio level.

Income: Accumulation share classes, the dividend is reinvested.

Investment horizon: The risk and the reward of the product may vary depending on the expected holding period. We recommend holding this product at least for 5 years.

Currency: Your shares will be denominated in Euro, the Fund's base currency.

Processing and redemption orders: You can buy and sell your shares daily.

Depositary: Société Générale Luxembourg

Intended Investor: This share class is intended for professional investors and eligible counterparties. The fund is dedicated to investors who seeks growth of capital and may bear total capital loss. Potential investors should have an investment horizon of at least 5 years.

WHAT HAPPENS IF Société Générale Private Wealth Management S.A. IS UNABLE TO PAY OUT?

Société Générale Private Wealth Management (SGPWM) is a management company licensed and supervised by the CSSF. SGPWM complies with organizational and operational rules, in particular as regards capital requirements. A separate pool of assets is invested and maintained for each Sub-Fund. The assets and liabilities of the Sub-Fund are segregated from those of other sub-funds as well as from those of the management company, and there is no cross-liability among any of them. The Sub-Fund would not be liable if the management company or any delegated service provider were to fail or default.

WHAT ARE THE COSTS?

The Reduction in Yield ("RIY") shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. The figures are estimates and may change in the future. You should note that these costs are paid by the Company whereas the return that you may receive will depend on the Company's share price performance. There is no direct link between the Company's share price and the costs that it pays.
